BWF **PRESIDENT'S** SUMMARY

As it is my final year as President, I will soon be handing over the reins to the Vice President, Andrew Madge, but before I do, this report provides an opportunity to reflect on the past 12 months and to share with you the achievements of the British Woodworking Federation.

I have been hugely proud to be the President of the British Woodworking Federation, working closely with the Board, Council and BWF team. We strengthened the **Governance** of the Federation by welcoming two new Board Members: Alison de Roeck from Kierson Sash Windows and Simon Badham from Arden Windows Ltd, as well as increasing the number of members on the BWF Council. When I came on board as President in 2021, I set out a plan to focus on three areas fundamental to supporting the growth and future success of our sector: supporting BWF member business growth; attracting and training the next generation of talent into our sector and, ensuring that sustainable construction doesn't slip down the agenda when the world was recovering from the aftermath of the pandemic.

As ever, **Members' Day** in June provided a unique opportunity to listen to your views and share best practice. We had 4 key speakers covering topics relevant to members such as when an inspector calls from the Health and Safety Executive (HSE), Consumer Rights and what this means to BWF Members, the future of construction product testing and legal duties for a woodworking company. We were thrilled to have over 100 members in attendance for this event.

As your dedicated industry Trade Association, we are committed to finding ways of working alongside industry partners to try to address these challenges on behalf of our members whilst continuing to raise the profile of the timber and woodworking industry. Through our strong relationships with several parliamentarians and governmental departments we are able to offer advice and guidance. As such, we are proud to be one of the key stakeholders working with the Department for Environment, Food and Rural Affairs (DEFRA) on the **Timber in Construction Road Map (TiC)**, which was launched by Rebecca Pow, Parliamentary Under Secretary of State (Minister for Nature) December 2023. Through the TiC the government has committed to increase the safe use of timber in construction in England, help reduce embodied carbon in the built environment and drive investment into tree planting, forest management and domestic supply chains, creating new green jobs and industries. A very positive move for the industry, one we should all be able to embrace.

This year we celebrated our **15th Annual Awards** at the prestigious Langham Hotel in London. As President, I find it extremely uplifting to see the BWF Awards event going from strength to strength. This event provides the opportunity to raise the profile of the sector and our members, and shines a spotlight on the incredible work we do and the amazing people we employ.

Finally, I have thoroughly enjoyed meeting so many of you in my three-year tenure as President. It is clear we have another year to be proud of, the team continue to drive best practice and standards, whilst championing the quality and professionalism of our sector. We have ambitious goals and a busy year ahead. But with a clear strategy, a committed team and under Helen's leadership, we are in great shape to achieve our collective mission.

BWF'S CEO SUMMARY 2023

The last 12 months have very busy for the British Woodworking Federation. Our industry has faced significant and persistent hurdles, from supply chain disruptions to escalating material costs and ongoing labour shortages. The operating environment for many companies has been very tough, yet we have pushed on through it together.

As your dedicated industry Trade Association, we continue to find ways of working alongside industry partners to try and address many challenges on behalf of our members and continue to raise the profile of the timber and woodworking industry. The timber industry has long advocated the use of timber to reduce the embodied carbon impact of construction. With the Government's 2025 net zero targets looming closer, the BWF joined the working committee responsible for developing the **Timber Industry Net Zero Roadmap** which was launched early 2023. The road map sets out the causes of emissions within the supply chain and proposes steps the industry could take to reduce these and what the journey to Net Zero could look like. This will run parallel with the Timber in Construction Road Map (TiC) which aligns with the four pillars of our Built It Better With Wood Campaign.

As an industry we are heavily regulated. This year has been a particularly busy year with several regulatory consultations running consecutively. In the early part of the year, the Department for Levelling Up, Housing and Communities (DLUHC) opened their consultation on sprinklers, Approved Document B and stairs. A BWF response was submitted in March but we are still to hear anything from the Government on the outcome. We also have the revision of **Approved Document K** and, towards the end of 2023, the **Future Homes** and Building Standards consultation, which aims to improve the energy efficiency and reduce the carbon emissions of new homes and non-domestic buildings. Energy efficiency requirements for new homes and non-domestic buildings are set out in **Part L and Part** 6, all of which is relevant to BWF Members. Our overarching goal is to help you, a BWF member, to navigate these changes and we use our collective voice to communicate your concerns and views.

Visibility in the industry is key, so we invested significantly last year in updating and refreshing the **BWF website pages** and the **Members Area Portal**. Since introducing these changes, we have seen traffic to the Find a Member page increase by 17%, with the page being consistently in the top 5 most viewed pages. This service offers members a huge opportunity to increase their own public profile to help promote their company and services to their customers. Think of it as another shop window for your company, so make sure your profile is up to date. Not only do we see regulatory changes happening within our sector, we also know there is a

As your trade association, we continue to stand by your side and work tirelessly to develop initiatives and strong collaborations and have made a number of notable achievements throughout the year. This provides a platform to continue to increase the Federation and its member's external profile. We released two reports; 'Have we Lived Up to The Standards on Fire Door Safety' Report which aimed to continue to increase awareness of the benefits of fire door third-party certification; and the **Challenging Misconceptions** on Timber Doors and Windows' Report. This report provided valuable insight for members into house builders' and homeowners' attitudes to timber windows and doors to help overcome some of the outdated perceptions surrounding timber products. The report also looked at housebuilders and homeowners' top priorities when making buying decisions, and how to bust some of the myths around timber-based products when competing against other materials such as aluminium and uPVC.

The BWF industry schemes - the Fire Door Alliance and Stair Scheme continue to champion best practice and high standards. The schemes and their members promote the importance of certification and accreditation to a variety of users and stakeholders.

deeper focus on the skills and competence of the people we recruit and employ. New figures from the Construction Industry Training Board (CITB), revealed in January 2024, stated

that almost 225,000 extra workers will be required to meet the UK construction demand by 2027. Recruitment, training, development and upskilling remained a major priority for the BWF in 2023. We continued to promote our **WOW I Made That** schools programme, aimed at attracting new recruits into the sector. This programme was named by DEFRA in the TiC Roadmap as one of the ways of attracting talent, which was a proud moment for the BWF. We remained very active during **National Apprenticeship Week** in February, showcasing some of the apprentices our members employ, and continued the work in reviewing the National Occupational Standards (NOS). These are focused on Wood Occupations and Site Carpentry and **Passive Fire** functions.

In April 2023 we launched the Level 3 Award in Fire Door Safety in partnership with City and Guilds. The gualification is embedded as a mandatory unit in the **Level 3 Site** Carpentry and Architectural Joinery Apprenticeship alongside the SiteRight Fire Door Installation Awareness Course with the National Open College Network (NCON). Understanding routes to competence is a priority for the BWF, therefore we started our work on a **Pathway to Competence** which will help map out the industries routes to entry, the roles on offer in our sector and opportunities for progression to help go towards increasing the external profile in a competitive employment market.

Heritage and Conservation is another focus for the BWF which aligns well with the recent consultation on the energy efficiency drive for historic homes, while protecting the beauty of the buildings. Last year we surveyed our members supplying Heritage and Conservation products and services and set up the **Heritage and Conservation Joinery Working Group** to drive this initiative forward in 2024.

Now more than ever, we need to build on what we have achieved throughout 2023, grab the opportunities available to us and work together to become even stronger as a sector. There are many exciting plans in the pipeline for the BWF over the coming year. The BWF team are always available to help and quide members with our strategic objectives and values informing all of our activities to make the BWF your **first port of call**. No matter how big or small, Membership is at the heart of what we all do.








CODE OF CONDUCT





Scheme News: After a long and thorough due diligence process, the BWF Fire Door Alliance is delighted to welcome IFC Certification and UL Solutions as providers of third party certification for timber fire doorsets and assemblies into the Scheme. The new partnerships increase the reach and strength of the BWF Fire Door Alliance in the construction sector as well as offering members further opportunities to become third party certified.

TIMBER FIRE DOORS ON THE MARKET IN 2023

With the ongoing challenges in the economy we saw a reduction of 6% certified doors placed on the market during 2023 compared to 2022. We estimate that over 2.1 million BWF Fire Door Alliance member certified fire doors were placed on the market in 2023.

FDA GOVERNANCE

The Advisory Committee is the main elected Committee of the BWF Fire Door Alliance and is responsible for upholding the aims of the Alliance and to represent the interests of the members, as laid out in the rules of the Fire Door Alliance. 





NEW BWF REPORT CHALLENGING MISCONCEPTIONS - HOMEOWNER AND HOUSEBUILDER ATTITUDES TO WINDOWS AND DOORS

We at the BWF know that timber products look beautiful, are sustainable and offer exceptional long-term value. However, we also know that there are still outdated perceptions and myths surrounding the properties of timber.

To find out more about buyers' perceptions over timber windows and doors, we commissioned a survey of housebuilders and homeowners. The findings, outlined in our report 'Challenging Misconceptions - Homeowner and Housebuilder attitudes to Windows and Doors', revealed that, while the aesthetic and value-adding aspects of timber products are recognised, housebuilders and homeowners alike mistakenly perceive timber maintenance to be far more onerous than is actually the case.



The Wood Safety Group membership is made up of Trade Associations representing the timber and timber manufacturing sector. The Secretariat is provided by the Health and Safety Executive (HSE).

The Timber Industry Road Map to Net Zero which was launched early 2023. The road map sets out the causes of emissions within the supply chain and proposes steps the industry could take to reduce these and what the journey to Net Zero could look like.

Glass and Glazing Federation (GGF) - The BWF joined forces with the Glass and Glazing Federation and Community Wood Recycling to support timber window frame recycling across the construction industry.

National Fire Chiefs Council (NFCC) - The BWF met with fire engineers from the NFCC to provide guidance on correct maintenance of timber fire doors to held disseminate information to fire brigades. Also worked on giving advice on "rogue" companies offering products that the NFCC have concerns over.

Passive Fire Protection Forum (PFPF) Following on from the release of the Testing for a Safer Future Report, the PFPF have reunited to review the recommendations and are looking at how the PFPF can be reinvigorated as a collective voice to represent the passive fire industry.

FIREX is the UK leading fire safety event. The BWF attended as a quest speaker to talk about timber fire door safety, implications of the proposed changes in National Classifications and the important of a fire door.

Timber Industry Net Zero Roadmap

Construction Leadership Council (CLC) Product Availability Group – the BWF has a regular place on the group which meets monthly with a representative from BEIS to continue to respond to construction related issues.

Relaunched the PFPF quide for undertaking technical assessments of fire performance of construction products based on fire test evidence.

Wood Knowledge Wales – supported and attended the WoodBuild 20023 Conference

Building Safety Charter – BWF signed the Building Safer Charter as a supporter showing its commitment to putting building safety first and demonstrating cross sector leadership.

Installer Competence Steering Group – Super Sector Forum –

a pan industry committee responsible for setting, developing and delivering at scale the process for rolling out the creation of competence frameworks for installers of construction products across industry. The aim is to set a clear measure of what the competency of an individual will be for each occupation in the construction industry. The BWF's involvement

Envelope Sector

- Firestopping Specialist Sector Group (FSSG) launched the Competence Framework for firestopping activities and specialist occupations.
- Door, gate and shuttering Sector Group (DGSS) is responsible for developing and overseeing implementation of the competence framework for the appropriate occupations within the DGSS sector. The BWF is leading on the work for mapping the competency of timber fire door installers. This will be launched in 2024.

Interiors Sector

• Stairs and 1st Fix Carpentry Group – Launched in December, the BWF is leading the group who will be developing and overseeing the implementation of the competency framework for occupations linked to installing timber staircases and products that are deemed first fix within a building.

2023 was a very busy year with various consultations and policy changes relevant to members. The BWF have been actively involved in shaping industry legislation and continue to represent the collective member voice in various committees and working groups. Sector wide business support through Government Consultations and Regulatory Commitments



FORUMS AND WORKING GROUPS

TIMBER IN CONSTRUCTION ROAD MAP (TIC)

The BWF was an active member of the Timber in Construction Working Group. This is a joint government initiative run by Department for Environment, Food and Rural Affairs (DEFRA), the Department for Levelling Up, Housing and Communities (DLUHC), the Forestry Commission, and industry, which aims to overcome the barriers in place for timber, and create a clear, joined up policy environment.

The Timber in Construction Road Map (TiC), was launched by Rebecca Pow, Parliamentary Under Secretary of State (Minister for Nature) in December 2023. Through the TiC, the government has committed to increase the safe use of timber in construction in England, help reduce embodied carbon in the built environment and drive investment into tree planting, forest management and domestic supply chains, creating new green jobs and industries.

The Timber in Construction Working Group will continue to meet regularly to track delivery of the actions outlined in the roadmap and to scope and implement new actions as needed. DEFRA will be developing a framework to monitor and evaluate progress on the roadmap's objectives, including its alignment to wider net zero and resource efficiency monitoring and evaluation frameworks.

The BWF has been keeping abreast of the changes to the way Construction Products are regulated in the UK following Brexit and the Building Safety Act 2022. The BWF regularly attends meetings of the Construction Leadership Council's Standardisation and Regulatory Alianment Committee.

OFFICE FOR PRODUCT SAFETY AND STANDARDS (OPSS)

The OPSS is the national regulator for consumer products. We continue to work with the OPSS to help inform their operational approach for enforcement officers, and to help them understand the regulations, standards, certification schemes and data available in relation to fire doors.

DEPARTMENT FOR BUSINESS, ENERGY AND INDUSTRIAL STRATEGY (BEIS)

The BWF met with the research company responsible for the BEIS Study – Construction Products Supply Chain and fed back on their questions and survey. The survey focused on a selected range of construction products, including cables, cladding, fire barriers, fire doors and insulation. The data collected informs the wider BEIS team and government.

DEPARTMENT FOR EDUCATION (DFE)

The BWF continued working with the DfE to address the lack of trained and skilled trainers and assessors in the woodworking, carpentry and, joinery sector. The DfE is looking at ways they can set up a pilot scheme to address trainer assessor shortages to increase provision and access across England.

CONSTRUCTION PRODUCTS REGULATION

COMPETENCE STEERING GROUP (CSG)

The Steering Group on Competence for Building a Safer Future, known as the Competence Steering Group (CSG) was set up to tackle competence shortcomings identified in the 2018 Hackitt Review - Building a Safer Future,

- Working Group 12 (WG12) is the working group for construction products competence. BSI has accepted the business case for the white paper launched in September 2022 "Built environment – proposed construction product competence standard" to form the basis of a new standard BS 8670-2 Built environment. Core criteria for construction product competence. Code of Practice. Drafting of this new standard is underway.
- Working Group 2 (WG2) is tasked to agree a comprehensive and coherent framework for assuring competence levels for individuals installing and maintaining fire safety and other safety-critical systems for HRBs



POLICY INFLUENCING

- 1. Department for Environmental Food & Rural Affairs (DEFRA) launched the Timber in **Construction Roadmap (TiC).** The BWF was a key stakeholder in the development of the road map.
- 2. Department for Levelling Up, House and Communities (DLUHC) Sprinklers in care homes, removal of national classes, and staircases in residential buildings consultation.

The consultation opened at end of 2022 is a serious concern for the BWF and members who manufacture in accordance with BS 476. The government recommendation is for the standard to be replaced with an European Standard EN 1634-1.

The industry is still awaiting the government's response on the outcome of the consultation, which closed in March 2023. The BWF have drafted letters for Parliamentary supporters including Clive Betts MP, Bob Blackman MP, Andrew Lewer MP and Sir George Howarth MP to send directly to the Minister for Building Safety setting out the Federation's concerns and policy asks. We have also encouraged Parliamentary supporters to table a series of probing written Parliamentary Questions on the consultation and lack of Government response throughout the year; and drafted and sent a letter to the Minister for Building Safety on national fire door testing standards.

The 'Have we Lived Up to The Standards on Fire Door Safety' Report issued by the BWF Fire Door Alliance provided clear data and statistics to support our policy asks on ensuring the new building and fire safety system is fit for purpose, securing further meetings with relevant parliamentarians.

3. HM Revenue and Customers (HMRC) Consultation on VAT energy saving materials relief - improving energy efficiency and reducing carbon emissions. The BWF prepared a briefing paper on the VAT energy saving materials relief consultation setting out the Federation's position and shared copies with high-level HM Treasury and HMRC Ministerial and Special Adviser targets including Victoria Atkins MP (Financial Secretary to the Treasury)

4. Historic Environment Scotland. The BWF took part in research into the impact of potential VAT rebate for extensions, repair and maintenance of listed buildings in Scotland. The report will be available in 2024.

5. Office for Product Safety & Standards (OPSS). The BWF has been working with the OPSS who is the national regulator for consumer products. We have been working with the OPSS to help them understand and develop their operational approach for their enforcement officers for timber fire doors and inspection schemes.

SKILLS AND TALENT DEVELOPMENT

Recruitment, training and access to apprenticeships and qualifications remains a core priority for the BWF. We know from the Building Safety Act 2022 that there is a significant drive and deeper focus on the skills and competency of the people we recruit and employ in our industry, in particular on the competency of individuals installing construction products. We also know that competition from other sectors for workers is more intense and skills shortages persist, indicating that too few have been joining the construction industry.

In response to this challenge, we continue to focus on attracting, training and retaining individuals in the woodworking and joinery sector whilst providing training support to BWF members.

The BWF's WOW I Made That education programme is named in the recently launched Timber in Construction Road Map by DEFRA in the **Priority theme 3: increasing skills**, capacity and competency across the supply chain, "continue to promote timberrelated careers in schools, colleges and more widely, for example through the British Woodworking Federation's 'WOW! I made that' initiative".

QUALIFICATIONS, STANDARDS AND TRAINING DEVELOPMENT

In supporting the provision of apprenticeships vocational qualifications, the BWF remains committed to reviewing and updating National Occupational Standards (NOS), which is the platform for qualification development.

APPRENTICESHIPS

Uptake of construction and engineering apprenticeships has risen for the first time in six years, which is good news. As such, the BWF continues to work with education partners, awarding organisations and other stakeholders to maintain, review and develop sector apprenticeships.



The BWF's involvement in the Level 5 Historic Buildings Apprenticeship continued in 2023 leading to the Institute for Apprenticeship and Technical Education (IfATE) approving the qualification.

FIRE DOOR INSTALLATION TRAINING

In April 2023, the BWF and City and Guilds (C&G) jointly launched the new Level 3 Award in Fire Door Safety Award to assist in increasing the skills and knowledge of timber fire doors installation in the sector. This is a mandatory unit which sits alongside the NOCN SiteRite Fire Door Installation Awareness Course in the Level 3 Advanced Carpentry and Architectural Joinery Apprenticeship.



CONSTRUCTION T LEVEL ACTION GROUP

T Levels are technical-based qualifications in England, developed in collaboration with employers and businesses, with content that meets the needs of industry and prepares students for work, further training, or study. T Levels are two-year courses that can be studied by 16-18 year olds after finishing their GCSE's. Students can specialise in carpentry and joinery. This is currently being piloted by CITB with the BWF as a member of the Steering Action Group.



1 Accounting policies

Company information

British Woodworking Federation is a private company limited by guarantee incorporated in England and Wates. The registered office is The Building Centre, 25 Store Street, London, WC1E 78T.

- 1.1 Accounting convention
- Accounting convenience is a seen prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" (FRS 102) and the requirements of the Companies Act 2006 as applicable to companies subject to the small companies regime. The disclosure requirements of section 1A of FRS 102 have been applied other than where additional disclosure is required to show a true and fair view.

The financial statements are prepared in sterling, which is the functional currency of the company. Monetary amounts in these financial statements are rounded to the nearest £

The financial statements have been prepared under the historical cost convention, modified to include certain financial instruments at fair value. The principal accounting policies adopted are set out below.

The company has taken advantage of the exemption under section 399 of the Companies Act 2006 not to prepare consolidated accounts, on the basis that the group of which this is the part qualifies as a small group. The francial statements present information about the company as an individual entity and does not include the results of FDIS Limited of which BWF owns 100% of the share capital at the balance sheet date.

Classification of financial liabilities

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into. An equity instrument is any contract that evidences a residual interest in the assets of the company after deducting all of its liabilities.

Basic financial liabilities

Basic financial liabilities, including creditors, bank loans and loans from associated companies, are initially recognised at transaction price. Financial liabilities classified as payable within one year are not amortised.
